Then look at your own damn evidence. The drug, the blood on Bryn's shirt, access to the saddle. All roads lead to Zoe. The sooner you accept that, the sooner we put away Bryn's killer.

TIME CUT TO:

INT. PRISON - VISITING ROOM - DAY

Bud slides a BOX of succinylcholine across the table to Zoe.

BUD

Succinylcholine. There's a vial missing.

ZOE

So?

BUD

It's what killed Bryn. Your prints were on the box which we found in the stable office.

(CONTINUED)

Bud shows Zoe a printout -- phone records.

BUD (CONT'D)

Someone's been using the phone there to call your family. A guard saw you arguing with Bryn outside the office a couple hours before she was found dead.

(off Zoe)

She caught you using the phone, didn't she? She told you to stop and you snapped.

ZOE

I didn't kill Bryn.

(then)

We were arguing because I wanted her to stop calling my mom.

BUD

Bryn made those calls?

ZOE

(a nod... then)
She was trying to convince my mom
to let my kid see me.

BUD

Why did that make you angry?

ZOE

Because you can't convince people you've changed if they don't want to believe it.

Bud studies Zoe a beat. Still, there's the evidence.

BUD

Why were your prints on the box?

ZOE

Bryn asked me to put that box back in the cabinet. She had just stopped someone from putting a horse down. She kept saying that the horse was proof.

BUL

What did the horse look like?

ZOE

It was a white one.

CONTINUED: (2)

BUD

Funny how all your alibis can't talk. First Bryn, now a horse. You better not be lying to me.

INT. POLICE STATION - BULLPEN - DAY

Bud at his desk. OFFICER JASON GALL, 20's, hands him a report.

JASON

Detective? I ran Paisley for you. There were no restraining orders or complaints filed by Bryn Walker.

BUD

Thanks.

Jason moves off. As Bud reads over the report --

EVELYN (O.S.)

Detective Morris?

Bud looks up to see EVELYN REESE, 50's, and her granddaughter, LAILA REESE, five years old, adorable.

EVELYN (CONT'D)

I'm Zoe's mother. This is Laila.

LAILA

Hi.

EVELYN

I understand you have some questions about my daughter?

INT. M.E.'S OFFICE - MEGAN'S OFFICE - DAY

Megan types something into her computer. ANGLE ON MONITOR: a Google entry for "The Four Horses" -- pages of results pop up. Megan leans back, sighs. Peter enters.

PETER

That was a big sigh.

MEGAN

Trying to figure out what Bryn's tattoo meant.

PETER

There's always Ethan's Apocalypse theory.

(CONTINUED)

MEGAN (CONT'D)

I think this reminded Bryn that people needed a push, a kick... something, someone to help them believe they could be something better than they were.

PETER

MEGAN

The car accident was my whip. It broke me and it brought me back to Lacey. What if I mess up again?

PETER

You won't.

TRANSITION TO:

INT. PRISON - VISITING ROOM - DAY

It's family visiting hours. Bud enters to find Zoe waiting for him at a table.

BUD

We caught Bryn's killer.

Zoe simply nods. Bryn being gone is still a loss for her. Bud studies her a beat, then... let the healing begin --

BUD (CONT'D)

Corrections wants to keep Bryn's therapy program going. There will be a job for you there once you're out.

ZOE

I appreciate that.

BUD

Oh, there's something else --

Bud nods to a GUARD, who opens the door to reveal Zoe's mother Evelyn and daughter Laila. They walk over to Zoe.

ZOE

Oh, my gosh... hi baby.

EVELYN

Laila, you remember your mom?

LAILA

Mommy?

ZÓE

You're so beautiful.

Sol

Zoe holds out her arms and Laila steps into them, giving Zoe a big, wide-armed hug. Bud and Evelyn trade a look.

INT. MEGAN'S APARTMENT - NIGHT (NIGHT 3)

Megan and Todd sit with Lacey.

TODD

Your mother and I talked it over and we were wondering if you would like to stay with her more often.

MEGAN

No pressure... if you don't want to, that's okay.

LACEY

No, I... I would like to.

MEGAN

Okay.

TODD

We can come up with a schedule. Something you can count on, maybe every other weekend to start.

LACEY

Does that mean I can stay with Mom this weekend?

TODD

Sure.

LACEY

And I can go to the party?

Todd and Megan trade a look. Let the real parenting begin,

INT. TODD'S CAR - NIGHT

Todd gets in. Kate is in the passenger seat.
